1. LEGAL NOTICE, INFORMATION AND ACCEPTANCE

This legal notice and information (hereinafter, the “Legal Notice”) governs the use of the web service of the Internet “www.cognit.es” that COGNIT NRG S.L. available to Internet users.

The use of the website gives the status of user (hereinafter the “User”) and implies full and unreserved acceptance of each and every provision of this Legal Notice as published by COGNIT NRG S.L. at the very moment when the user accesses the portal.

4. PROTECTION OF PERSONAL DATA

Who are the recipients to whom the data are disclosed?

Cookie is a file that is downloaded to your computer to access certain web pages.
